

## **Terms & Conditions of RM Education's "Lenovo 11e" offers**

By purchasing the specified number of devices as per clause 3 below (the "Offer"), the educational establishment is deemed to have read, understood and accepted (i) the RM Terms and Conditions of Sale and the RM privacy policy (both of which can be found at [www.rm.com/about/terms](http://www.rm.com/about/terms)) and (ii) these terms and conditions, and will therefore be legally bound by them.
2. The Offer is open to all education establishments in the UK from 11<sup>th</sup> September 2017 until the 16<sup>th</sup> October 2017.
